

Privacy Policy

This privacy policy addresses Booyah Networks, Inc.'s current practices and policies with regard to data collected through this web site. The term "personal data" refers to personally identifiable information about you, such as your name, mailing address, e-mail address, telephone number, and any other information that identifies you personally.

Your Consent

By using this web site or any web site belonging to Booyah Networks, Inc., you consent to our use of your personal data as described in this privacy policy.

Changes

If there are any changes to this Privacy Policy, we'll post them on the Website. Any changes will be effective as of the date we post on the Website.

Personal Data Collected Through This Web Site

We may ask you to voluntarily provide personal data (e.g., name, physical and e-mail addresses, company name, telephone number, etc.) in order to request our services or use certain features of our websites. For example, if you wish to leave us a message online, we will ask you for personal information in order to respond.

We do not sell your personal data.

We use the personal data you provide to manage the services you request and respond to inquiries from you. We may also use your personal data to support our relationship with you by sending you materials or contacting you about services or offers that we think would be of interest to you.

At all times, we will process your data fairly and lawfully. We will retain your personal data for as long as is necessary for the purposes stated above.

We share your personal data with authorized Booyah Networks, Inc. personnel and third parties who are acting on our behalf in order to provide the services you request or to support our relationship with you.

We participate in the The LeadLander Contact Network. The LeadLander Contact Network pools together contact information collected through our contact forms and any other LeadLander opted-in website forms or email campaigns to identify a visitor to the booyahadvertising.com website.

We may also disclose your personal data if we are required to do so in order to comply with our legal obligations.

Anonymous Data Collected Through This Web Site

In addition to the information you provide when you use our web site, Booyah Networks, Inc. uses technology to collect anonymous information about the use of our web site. For example, we use technology to track how many visitors access our web site, the date and time of their visit, the length of their stay, and which pages they view. We also use technology to determine which web browsers our visitors use.

This technology does not identify you personally. It simply enables us to compile statistics about our visitors and their use of our site. Booyah Networks, Inc. uses this anonymous data and may share it with third-parties for various reasons, for example, to improve the content and functionality of our web site, to better understand the needs and interests of our visitors, to improve our programs and services.

Cookies

In order to collect the anonymous data described in the preceding paragraph, Booyah Networks, Inc. uses “cookies”. Cookies are small pieces of data or data files, which are sent by a web site to your browser and stored on your computer. They are used to understand general traffic patterns on our web site. The information stored in the cookies is only used for statistical tracking purposes and not for individual identification. Cookies do not damage your computer. In order for certain applications on Booyah Networks, Inc.’s web sites to function properly, if at all it is necessary for your computer to accept cookies. You can set your browser to notify you when you receive a cookie. This enables you to decide if you want to accept it or not.

Children

Booyah Networks, Inc. does not knowingly collect personal data from children under the age of thirteen. If you are under thirteen, please do not give us any personal data. If you have reason to believe that a child has provided personal data to Booyah Networks, Inc., please contact us, and we will endeavor to delete that information from our databases.
